# Introduction

The Virginia Commonwealth University Health System (VCUHS) is the only academic medical center in central Virginia. As the regional teaching institution, we offer access to some of the most advanced state-of-the-art treatments and technologies available. Our medical staff includes internationally recognized physicians, dozens of whom have been recognized among the best doctors in the country. Many VCUHS physicians also have been ranked among the top doctors in Richmond in specialties ranging from allergies to vascular surgery. And for several years running, we've been selected by many of the rating organizations including National Research Corporation's Consumer Choice, Solucient "Top 100" Hospitals, U.S. News and World Report, and as a technology leader by being recognized as one of the "Most Wired" healthcare institutions.

Since 1838, the Medical College of Virginia Hospitals (MCVH) has been on the forefront of advances in healthcare, providing patients with some of the most progressive treatment and technology available. The July 2000 transition to the Virginia Commonwealth University Health System (VCUHS) was another innovation. The change allows the VCU Health system to continue providing the state-of-the-art care on which our patients have depended for more than 160 years.

MCV Hospitals is the teaching hospital component of the VCU Health System, which also includes a number of outpatient clinics and MCV physicians, a 600 physician faulty group practice. VCUHS, as the clinical delivery component of the VCU Medical Center, is the only academic medical center in central Virginia and is a regional referral center for the state. With 779 licensed beds, MCVH has approximately a 20% share of the Richmond inpatient market. VCUHS records 30,000 admissions and more than 500,000 outpatient visits each year. Over 80,000 patients are treated annually in the hospital's emergency department, which is the region's only Level I Trauma Center.

The VCU Health System comprises nearly 200 specialty areas, many of national and international note. In addition to multidisciplinary centers for cancer, cardiology, neurosurgery, and transplantation, VCUHS offers virtually every form of contemporary medical service. In particular, VCUHS has received international recognition for early diagnosis and treatment of chest pain and strokes, organ transplant, head and spinal cord trauma research, burn and wound healing, neonatal intensive care, and genetic research, as well as cancer research, treatment, and rehabilitation.

VCUHS delivers oncology patient care services for VCU's Massey Cancer Center, a National Cancer Institute designated facility, which offers patients many multi-disciplinary treatment options and access to clinical research trials. VCUHS has been recognized in the past by U.S. News and World Report for its leadership in neurology, neurosurgery, orthopaedics, respiratory disorders, digestive tract, rehabilitations, and gynecology. Recently, the VCUHS received ranking in 2007 and 2008 as one of America's Best Hospitals. Other awards include the 2003 Solucient "Top Hospitals" award, as well as recognition of 68 physicians as part of the "2008 Best Doctors in America".

Making medical history is only part of the reason for the excellent reputation of the VCUHS. Thanks to the dedication, compassion, and expertise of its approximately 7,000 staff members, from doctors, nurses, and resident medical staff, to support personnel and administrators, VCUHS has enjoyed a consistently high patient satisfaction rating. All of this combines to strengthen the VCU Health System's position in the healthcare marketplace and protect our important mission of excellence in research, education, and patient care for the 21st century.

# **SCOPE OF SERVICES**

The Clinical Services of the Department of Pathology are grouped into divisions of Clinical Pathology, Anatomic Pathology, and Cellular Molecular Pathogenesis. The Department of Pathology has extensive (world-renowned) professional expertise in all laboratory disciplines and provides consultation to clients and colleagues on technical, interpretative, management, and educational topics.

Each area of the VCUHS Pathology Service has a faculty member "on call" at all times for immediate consultation in handling difficult questions referred from pathology residents. This interactive network of communication is well organized and its performance and lessons learned are reviewed in the weekly resident report in which both clinical pathology faculty and residents have opportunity to comment on problematic cases. This collaborative, comprehensive, and consultative process is a truly exceptional value-added service that is not available from any other laboratory service in the Commonwealth of Virginia.

VCUHS Department of Pathology is conveniently located in downtown Richmond at the intersections of Interstate 95 and Broad Street. The Pathology Laboratories are primarily housed in the Clinical Support Center at 403 N 13th Street on the second, fifth, and sixth floors occupying 46,400 square feet of space. Some of the department's specialty laboratories (or Centers for Excellence) are located nearby in the Gateway Building: Anatomic Pathology and Transfusion Medicine Service and Apheresis Unit with 22,763 square feet, and

other ancillary areas with 3200 square feet. Altogether, the Pathology Laboratory operations maintain more than 69,000 square feet of space.

The VCUHS Department of Pathology clinical laboratories are certified by the Federal Government under the Clinical Laboratory Improvement Amendments of 1988, and are fully accredited by the College of American Pathologists and the American Association of Blood Banks.
